**Explanation of Responses:**

- The reported item includes an initial award of 2,837 shares of restricted stock which vests in three equal installments beginning on the first anniversary of the March 2, 2016 grant date. As of the date of this report, 946 of those shares have vested. Additionally, the reported item includes a de minimis correction to the balance reported on the reporting person's prior reports of an award of 100 shares of restricted stock which will vest in three equal installments beginning on the first anniversary of the September 1, 2016 grant date.
